Subject: - Additional requirement

In order to proof the quality of the bed net to be supplied we have noticed that it is critical to conduct pre-shipment inspection on the batch to be dispatched to the country. To conduct the assessment we kindly instruct the interested bidders to go through the following procedures:-

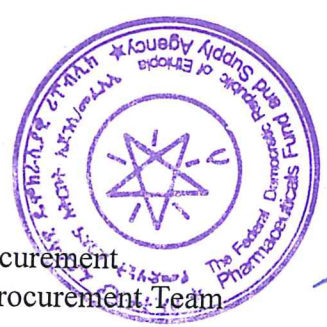
1. Sampling and randomization shall be performed according to WHO-related guidelines. Sampling of nets can also be based on the sampling procedures for “inspection by attributes” of the standards of the ISO 2859 series;
2. Sampling to be done by an independent ISO 17025- accredited laboratory or Good Laboratory Practices, sampling agent which shall be notified ahead of the inspection to the country Regulatory authority called as Ethiopian Food and Drug Authority. Then Inspection shall be carried out after approval of the authority.
3. Testing shall be done according to WHO approved specifications and methods of the Collaborative International Pesticides Analytical Council (CIPAC)
4. The price quoted for the products by the bidder shall include the cost of pre-shipment inspection and testing.

NB: - Bidders are expected to indicate their willingness to undertake the above stated activities in their bidding documents and failure to indicate will lead to rejection of the bids.
