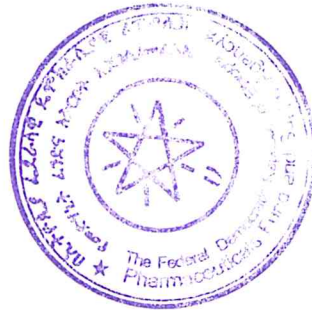
4. Clarification on the bid documents with letter dated on 12<sup>th</sup> December, 2019:
