3. Bids must be delivered to the address below **on or before 35 calendar days after the date this notice posted on the Ethiopian herald Newspaper before 2:00 P.M local time**. Late bids will be rejected. Bids will be opened in the presence of bidders or their representatives, who choose to attend in person at the Conference Hall of the Agency on the last day of bid submission at 2:30 P.M local time (For further detail refer to the Bid document that will be sold subsequently).


